**1.0 BASIS**

A petition for a Writ of Habeas Corpus has been presented by JAMES FAIRE, by and through his attorney Stephen Pidgeon.

**2.0 FINDINGS**

The Court has reviewed the records, files, affidavits, and heard argument, and deems itself fully advised in the premises.

**3.0 ORDER**

IT IS ORDERED:

That a Writ of Habeas Corpus, and Warrant in Aid of Writ of Habeas Corpus, be issued directing the Okanogan County Sheriff or any other peace officer of the State of Washington to locate and take JAMES FAIRE into immediate custody and to deliver him as soon as possible to the

1 Presiding Judge of the Superior Court of Washington in and for the County of Okanogan, located at  
2 131 3<sup>rd</sup> Avenue N., Okanogan, Washington 98801, where he is to be released on bail.

3 Said peace officers may break and enter any residence, building, structure, or vehicle in  
4 which they have reason to believe JAMES FAIRE is located or where information pertaining to the  
5 location of the person may be found; and

7 Said peace officers may arrest any individual who stands in the way or obstructs their rightful  
8 attempts to obtain the immediate custody of JAMES FAIRE; and

9 In the event the matter cannot be immediately heard by the Okanogan County Superior Court  
10 at the time JAMES FAIRE is placed into law enforcement custody, the Okanogan County Sheriff or  
11 any other peace office in the State of Washington is hereby commanded to release JAMES FAIRE,  
12 without further disposition of the court.
